### MEETING MINUTES September 11, 2024

#### I. Attendance/Call to Order

Roll call indicated that seven (7) voting members were present, and a quorum existed.

### II. Public Hearings

### a. 34 Central Avenue (Black Sheep & Co.) – Tracy Diegelman – Awning/Signage

Ms. Diegelman was present at the meeting. Proposed is a black awning, like that at Lancaster Coffee Co. down the street. Ms. Diegelman clarified that the lighting shown in the proposal is existing. The HPC discussed that the proposed signage follows the Signage Guidelines. There was no other discussion.

MOTION: S. Campbell made a motion to approve the COA as presented. Second by J. Kacala.

MOTION APPROVED: In a vote of seven (7) ayes to zero (0) nays.

Justification: This work is compatible with the historic district per the Secretary of the Interior's Standards for Rehabilitation, Number 10 – New additions and adjacent or related new construction shall be undertaken in such a manner that if removed in the future, the essential form and integrity of the historic property and its environment would be unimpaired.

### b. 12, 14, 16 West Main Street (Heritage House) - Mike Berger, Sutton Architecture - 2-Story Addition

Mr. Berger was present at the meeting. This project has had an initial review by the Planning Commission and Zoning Board of Appeals. Mr. Berger and his client, Dick Young, previously appeared before the HPC for a discussion with the Commission. Mr. Berger explained changes to the design since the previous discussion. Materials discussed for the design include real brick at the exterior, composite-clad balcony posts with wood balusters, and aluminum windows. The parapet should be tall enough to hide the rooftop mechanical units. E. Eckert made a statement that she would prefer the cladding at the balcony be dark colored instead of the shown white. S. Campbell stated that she walked West Main Street recently, and that the size and proportion of the balcony and awnings for the addition will fit in with the historic district and West Main Street. The Commission discussed that they have no opposition to the proposed design but will delay their vote until final materials are submitted.

MOTION: E. Eckert made a motion to table the COA. Second by S. Campbell.
